

Additionally, 01 02 03 12 shared some details about 01 02 03 12 and about 12/14/12 with Detectives, and he and 01 02 03 12 were offered the opportunity to reflect privately within 01 02 03 12 classroom prior to clearing the school.

The status of the case remains actively under investigation.
