-School Visit Report-

01 02 03 12 Family

Action Taken: On 5/24/13, this Detective, Newtown Police Officer Jeff Silver and Detective Peters #816, responded to Sandy Hook Elementary School, 12 Dickinson Drive, Sandy Hook, CT, for a prearranged school visit with 01 02 03 12. Also present was 01 02 03 12 had been present at the first two informational group meetings that were held for the decedents' families, and therefore was already aware of much of the investigative information that had been shared regarding the case. 01 02 03 12 were provided with, in part, the following information:

- information specific to 01 02 03 12 and his whereabouts within his classroom
- information regarding 01 02 03 12 proximity to his classmates, as permitted by the other decedents' families
- clarification of information pertaining to the ammunition, magazines and number of shots fired
- information pertaining to the path of travel the shooter followed in the impacted hallway
- information pertaining to some overheard verbalizations believed to have been made by the shooter
- information regarding the reports available from the Medical Examiner's Office
- information pertaining to the potential future return of some of 01 02 03 12 personal property and artwork
- clarification of some misinformation and rumors that circulated in the media about the investigation and actions of some of the decedents
- information pertaining to the shooter's apparel and use of earplugs
- clarification of some details about the engagement of the school intercom during the incident
- information pertaining to the movements of the teacher and students in classroom #12 (Roig)

01 02 03 12 was given the opportunity to walk through the impacted hallway and classrooms and some questions were asked by and answered for him by the officers present. Additionally, 01 02 03 12 shared some details about 01 02 03 12 and about 12/14/12 with Detectives, and he and 01 02 03 12 were offered the opportunity to reflect privately within 01 02 03 12 classroom prior to clearing the school.

The status of the case remains actively under investigation.
