-School Visit Report-

01 02 03 12 Family

Action Taken: On 8/16/13, this Detective, Newtown Police Officer Jeff Silver and Detective Mudry #824 responded to the Sandy Hook Elementary School, 12 Dickinson Drive, Sandy Hook, CT, for a prearranged school visit with 01 02 03 12 visited the school very early in the course of the investigation, and requested to revisit the site to clarify some information and details that had been relayed in the weeks and months after their initial visit. Also present was 01 02 03 12. The family was provided, in part, with the following information:

- details regarding some of the movements of the shooter in the days leading up to 12/14/12
- details regarding some information relayed by witnesses who knew the shooter due to his frequent visits to their place of employment
- clarification of some additional misinformation given out by the media
- details regarding the most up-to-date timeline, incorporating known times and partial transmissions from the audio recordings, 911 calls, radio transmissions, written reports and in-car video footage
- clarification as to whether or not 01 02 03 12 was one of the children transported via ambulance
- information pertaining to the police response to the school and who the first responders inside were
- clarification of where the gun safe inside the house was located
- information pertaining to the classroom layout and location of 01 02 03 12 assigned desk in the class at the time of the shooting

The family was provided with the opportunity to visit and reflect privately within 01 02 03 12 classroom prior to clearing the school.
