Action Taken: On 4/18/13, following an informational meeting held by State's Attorney Stephen Sedensky in Newtown, CT, this Detective and

Detective Jewiss met privately with **10**, regarding the ongoing investigation. **04** and therefore had already received much of the investigative information that had been relayed. **04** was provided with, in part, the following information:

-information regarding Mary's location as she was found within the school

-information regarding Mary's proximity to other victims, as permitted by themselves or their families

-information regarding what was stated by the adult witnesses with Mary inside Conference Room #9 prior to Mary leaving the room

-information regarding what was stated by the two injured teachers in the hallway at the time that Mary was shot

-clarification of some misinformation and rumors regarding the actions of some students and teachers during the incident


-information regarding the Medical Examiner's reports, what will be contained in them and the process for obtaining them

-information regarding the shooter's status and placement as a student in the school during his elementary years, and any evidence that Mary would have recognized the shooter as a student she had once worked or engaged with

offered his perspective on and experience with his Trooper Liaison as an example of something done well during the investigation.
