**ACTION TAKEN:**

On 08/30/13 at approx. 1430 hrs, Det. Rachael Van Ness #1431, Newtown Officer Jeff Silver and I met with [REDACTED] 01 02 03 12 [REDACTED] at the Sandy Hook Elementary School at 12 Dickinson Drive, Sandy Hook, CT. for a prearranged school visit. [REDACTED] 01 02 03 12 [REDACTED] had been present at a private family meeting between Det. Van Ness and I, and [REDACTED] 01 02 03 12 [REDACTED] family on 01/17/13, however not many investigative details were given to [REDACTED] 01 02 03 12 [REDACTED] at that time. [REDACTED] 01 02 03 12 [REDACTED] were subsequently provided in part with the following information:

- a very basic review of the sequence of events
- specific details that were known about [REDACTED] 01 02 03 12 [REDACTED], including where she was found by 1st responders
- the location of other victims in relation to [REDACTED] 01 02 03 12 [REDACTED], as approved by some of the other victims' families
- a viewing of the lobby, hallway, room #12 and room #8
- information about where the shooter was found dead
- clarification of some misinformation and rumors that had been released by the media

[REDACTED] 01 02 03 12 [REDACTED] were taken to the spot where [REDACTED] 01 02 03 12 [REDACTED] was found within her classroom and were afforded the opportunity to reflect privately within the classroom prior to clearing the school.
