Action Taken: On 9/10/13, this Detective contacted the family of 01 02 03 12

with regards to the ongoing

investigation. This Detective inquired as to whether or not the 01 02 03 12 were able to provide information regarding anything that their child had relayed pertaining to the school shooting, and was advised that at this time their child is just beginning to meet with a new trauma therapist due to the fact that leading up to this date, there have been no breakthroughs which have elicited discussion or information about the shooting from their child. This Detective was advised that as the rapport and relationship between the child and the new therapist develops, they will gladly share any information that is relayed, but that to date, they as parents still have no answers to even basic information from their child. This Detective relayed that if information is shared, a supplemental report can be generated at any point even if the case is suspended or closed.

On 9/10/13, this Detective contacted the family of **102 03 12** with regards to the ongoing investigation. This Detective left a message for the ^{01 02 03 12} requesting a call back, however, at the time of this report, have not yet had any communication with the ^{01 02 03 12} family.

The status of the case remains actively under investigation.
