
Action Taken: On 9/11/13, this Detective, Sgt. Bill Cario #149, Newtown Police Officer Jeff Silver and Detective Jewiss #336 responded to Sandy Hook Elementary School, 12 Dickinson Drive, Sandy Hook, CT, for a prearranged school visit with the 0102,03,12 Family.

The 01 02, 03, 12 had been present for many of the informational meetings held for the decedent families by the State Police, and therefore had already received much of the investigative information that had been shared to date. During the visit, the 01 02, 03, 12 were provided with, in part, the following information:

- -information specific to 10 02,03,12 and his location in his classroom
- -information pertaining to 0102,03,12 proximity to his teachers and classmates, as permitted by the decedent families
- -information relayed by the surviving students from Classroom 10
- -information pertaining to the movements within Classroom 12 (Roig)
- -information pertaining to the movements of the teachers and students within Classroom 8
- -information pertaining to the actions and movements of the teachers, staff and administrators in the impacted hallway and throughout the building
- -information pertaining to some verbalizations overheard within the school that are believed to have been made by the shooter

The 01 02, 03, 12 were afforded some time to reflect privately within 01 02, 03, 12 classroom prior to clearing the school.

After exiting the school, the 01 02, 03, 12 were given a folder containing a piece of 01 02, 03, 12 original artwork which had been removed from a bulletin board inside his classroom.

The status of the case remains actively under investigation.
