Action Taken: On 9/13/13 at approximately 0700 hours, this Detective, Detective Jewiss #336 and Officer Silver of the Newtown Police Department responded to 12 Dickinson Drive, Sandy Hook, CT, for a prearranged school visit with 01 02 03 12 100.

During the visit, the 01 02 03 12 were afforded some time to reflect privately within 01 02 03 12 classroom, and were also provided with answers to, in part, some questions they had pertaining to the ongoing investigation, questions about the shooter and his lifestyle and relationships, questions about the possible sequence of rooms that the shooting took place in and a projected timeline for the closing of the case.

The status of the case remains actively under investigation.
