-School Visit Report-

01 02 03 12

Action Taken: On 9/13/13 at 0830 hours, this Detective, Detective Jewiss #336 and Officer Silver of the Newtown Police Department met with **01 02 03 12** at 12 Dickinson Drive, Sandy Hook, CT, for a prearranged school visit.

01 02 03 12 had been present at many of the group informational meetings that have been held for the families of the decedents by the State Police, and therefore had already received much of the information that had been provided regarding the status of and known information pertaining to the ongoing investigation. During the visit, **01 02 03 12** was provided with, in part, with information specific to **01 02 03 12** and her location within her classroom and proximity to her classmates, as permitted by their respective families.

01 02 03 12 was provided with answers to some questions she had for both the CSP Detectives as well as Officer Silver, and was offered some time to reflect privately within **01 02 03 12** classroom if she wanted to prior to clearing the school.

The status of the case remains actively under investigation.
