ACTION TAKEN: On Friday December 14, 2012 at approximately 2300 hours I reported to the command post located within the Sandy Hook Fire Department on Dickenson Drive. While at the command post I was assigned a death notification detail for the 01 02 03 12 family. The death notification was for 01 02 03 12 who was in classroom number 10 at the Newtown Elementary School located at 12 Dickenson Drive. I was assigned one clergy member and one health clinician to aid in the notification. While reviewing the lead sheet I observed 01 02 name on the sheet. I made contact with 01 02 who stated that he had been with the family all day and stated he too would aid in the notification. We all went to the 01 02 03 12 address of 01 02 03 12 to make the notification.

Upon arrival at 01 02 03 12 we met at the door by 01 02 03 12. Upon entry into the residence we met with 01 02 03 12. We walked into the 01 02 03 12 family room and had both 01 02 03 12 sit on the couch next to each other. The notification was made at approximately 0045 hours. 01 02, the clergy member, the health clinician and myself stayed with the family for approximately thirty to forty five minutes comforting the family and answering questions. I issued the 01 02 03 12 two packets with Federal assistance programs and another containing stress management/ emotional management information.

After departure from the 01 02 03 12 I returned to the command post and gave the lead sheet paperwork to Sgt. Corey Eters #154.
