

---- INITIAL REPORT ---- (Sandy Hook School Shooting)

#### **ACTION TAKEN:**

On 12/14/12 at approx. 0935 hrs., members of the Newtown P.D., CT State Police and numerous other law enforcement and medical services responded to an Active Shooter incident at the Sandy Hook School located at 12 Dickinson Drive in Newtown, CT. The shooter, later identified as Adam Lanza (dob 04/22/1992), was found in the school, dead of an apparent self-inflicted gun shot wound. Also identified were the above listed twenty-six deceased victims, two gun shot victims and twelve other victims.

Western District Major Crime was assigned to investigate the incident, whereupon they established an investigative command post at the Newtown Emergency Operations Center located at 27 Mile Hill Road South. Several other CT State Police units and numerous other local, State and Federal agencies assisted in this investigation (refer to Supplement Reports).
