ACTION TAKEN:

On 11/08/13 at approx. 1630 hrs I met with ⁰⁴ [redacted] ^{01,02,03,12} at ⁰³ [redacted] ⁰³ [redacted] was a ^{01,02,03,12} [redacted] a victim of the Sandy Hook Elementary School shooting.

At this time I briefed ⁰⁴ [redacted] on the latest information specific to ^{01,02,03,12} [redacted] that would be in our State Police report and possibly be included in State's Attorney Sedensky's summary report, which was reportedly going to be released later that month. I subsequently answered several of their questions and offered them opportunities for more detailed information, which they declined at that time. Our meeting then concluded at approx. 1838 hrs.
