**ACTION TAKEN:**

On 11/15/13 at approx. 0915 hrs. I met with <sup>04</sup> [redacted] along with State's Attorney Sedensky in a private office in the Danbury Courthouse in Danbury, CT. The <sup>04, 03</sup> [redacted] <sup>01,02,03,12</sup> [redacted] who was a student <sup>01,02,03,12</sup> [redacted] and a victim of the Sandy Hook Elementary School shooting.

Neither the <sup>04</sup> [redacted] nor the <sup>04</sup> [redacted] had been present at the Group Family Meeting held on 11/14/13, and therefore had not seen SA Sedensky's case summary that he had written and was preparing to release to the public on 11/25/13. SA Sedensky showed <sup>04</sup> [redacted] the draft of his report and then allowed them time to read through it, along with its extensive appendix.

Also during this time, I briefed <sup>04</sup> [redacted] on the latest information that was specific to <sup>01,02,03,12</sup> [redacted] to include information that would be reported in our State Police report and possibly would be released in SA Sedensky's report. I also answered several questions for <sup>04</sup> [redacted] before the meeting was concluded at approx. 1045 hrs.
