ACTION TAKEN:

On 11/25/13 at approx. 1500 hrs., State's Attorney Stephen Sedensky released his summary report of the State Police investigations into the shooting at the Sandy Hook Elementary School and the shooting of Nancy Lanza.

In addition, on 12/19/13 he wrote a letter to the Western District Major Crime Squad Commanding Officer, LT David DeVecchia #034, advising him that his (SA Sedensky's) review of those investigations were complete and that due to the findings that the single shooter acted alone before he committed suicide, no prosecution was expected and the cases could be closed. He also included a copy of his report and its appendix however, since those items had already been entered into our case file (refer to Closing Report - dated 12/03/13), they are not included with this report (SEE ATTACHED LETTER).

Dear Lt. Delvecchia:

I have reviewed the Western District Major Crime Squad (WDMC) investigation into the shooting deaths at Sandy Hook Elementary School, Newtown, Connecticut on December 14, 2012.

I am satisfied with WDMC's thorough investigation and conclude after my review of all the investigations that all of the shootings at the school were done by Adam Lanza, who acted alone. As Lanza killed himself after committing the killings at Sandy Hook Elementary School, no prosecution of anyone is to be done. Absent information indicating otherwise, the investigation may be closed.

Enclosed for your file on a CD is a copy of my report with an appendix for both the December 14, 2012 shootings at Sandy Hook Elementary School and that of Nancy Lanza at 36 Yogananda St., both in Newtown, Connecticut.

Though I wish the circumstances were otherwise, I am proud and grateful to have had the opportunity to work with yourself and the members of the Western District Major Crime Squad.
