SUPPLEMENTAL REPORT: Review of Exhibit # 00372

ACTION TAKEN: During the course of this investigation, a comprehensive review of the shooter's computer hard drive revealed that he played and possessed an account for the Internet-based, multi-player, role-playing video game, **World of Warcraft**.

At the request of State's Attorney Stephen Sedensky, the Connecticut State Police prepared a Search and Seizure Warrant for all information associated with the account(s) and/or individual(s): "Peter Lanza and/or Nancy Lanza and/or Ryan Lanza and/or Adam Lanza and/or the physical address: 36 Yogananda Street, Newtown, Connecticut 06470" and all information associated with the character "**blarvink**" for the time frame of January 1st, 2009 thru December 31st, 2012. On 08/27/2013, a Connecticut Search and Seizure Warrant was issued and executed upon Blizzard Entertainment, Inc. On 09/09/2013, the records were seized by this Detective and a review of said records yielded the following results:

World of Warcraft supports gaming community communication features such as Internet Relay Chat (IRC). World of Warcraft affords its users the following four (4) means of IRC from which to communicate while gaming: "Chat Channels", "Custom Channel (user created for privacy)", "Voice Chat", and "Other Chat." There was no IRC information or chat content for either account noted within the records.

Lastly, there was no evidence of IRC communication or attempted IRC communication to indicate persons and/or co-conspirators, in the planning, execution, and/or cover up of the Sandy Hook Elementary School shooting ---> Please refer to Exhibit # 00372 for additional details.
