SUPPLEMENTAL REPORT: Review of Exhibit # 00373

ACTION TAKEN: During the course of this investigation, a comprehensive review of the shooter's computer hard drive revealed that the following two (2) e-mail accounts: "**blarvink@gmail.com**" and "**genericregistryemail@gmail.com**" were utilized as a means of communication by the shooter.

At the request of State's Attorney Stephen Sedensky, the Connecticut State Police prepared a Search and Seizure Warrant for all records associated with "**blarvink@gmail.com**" and "**genericregistryemail@gmail.com**" for the time frame of January 1st, 2009 thru December 31st, 2012. On 08/27/2013, a Connecticut Search and Seizure Warrant was issued and executed upon Google, Inc. On 12/02/2013, the records were seized by this Detective and a review of said records yielded the following results:

- 1.) The gmail account was created on 09/05/2007 at 2136 hours.
- 2.) A secondary e-mail titled "ZhouYu210@aol.com" was linked to this account.
- 3.) The gmail account contained a total of seventy-six (76) e-mails.
- 4.) The e-mails spanned the dates: 10/17/2008 - 11/30/2012.
- 5.) No Calendar events were created or associated with this account.

The e-mails contained in this account consisted primarily of conversations (sent and received) between the shooter and his three (3) immediate family members. The topic(s) of conversation and file sharing were related to day trip planning, attempted family visitation, and on-line purchases / reimbursement.

The most notable e-mail correspondence was one (1) dated 11/17/2010 where the shooter contacted a fellow World of Warcraft game player to apologize for his mood over the summer and stated that he was more depressed than he had ever been before. The shooter further stated that he would rather not play World of Warcraft anymore for various reasons, but did not actually say why. Ultimately, the shooter stated that he did not use the <blarvink@gmail.com> e-mail address anymore and provided the <genericregistryemail@gmail.com> e-mail address as an alternative one to use.

- 1.) The gmail account was created on 07/06/2008 at 1527 hours.
- 2.) A secondary e-mail titled "lanzaap@aol.com" was linked to this account.
- 3.) The gmail account contained a total of seventy-two (72) e-mails.
- 4.) The e-mails spanned the dates: 03/21/2011 - 12/14/2012.
- 5.) No Calendar events were created or associated with this account.

The e-mails contained in this account consisted primarily of conversations (sent and received) between the shooter and various other e-mail accounts. The topic(s) of conversation were exclusively related to killing sprees, mass murder, and school shootings. Electronic files were shared between the shooter and the other e-mail accounts and ranged from hyperlinks and videos to statistical spread sheets and song compilations, all of which were focused on killing. Furthermore, the other e-mail account holders had the same interest, fixation, and/or obsession with killing.

Additionally, throughout the correspondences the shooter continually conveyed through his own choice of words, how he felt mentally and emotionally. In some instances, the shooter stated he was depressed and/or in despair, while at other times, the shooter stated he was overjoyed and/or excited. It was also noted that the shooter's fluctuating mental and emotional trends, as well as the content of his writings, coincided with violent shooting incidents and/or mass casualty events.

When there was a significant incident or event, the shooter conveyed elation and contentment in his writings. When there was a period of time without a significant incident or event, the shooter conveyed misery and discontent in his writings. All the while, the shooter incessantly referenced the significant incident or event throughout his various communications. The following two (2) e-mails related the shooter's temperament:

On 07/23/2012, the shooter expressed disgruntlement about not having felt the enthusiasm he had once experienced in April 2007 when the Virginia Tech Shooting occurred!

On 12/11/2012, the shooter expressed excitement about the Clackamas Town Center Shooting that occurred in Portland, Oregon earlier that day. Conversely, not more than two (2) hours later, the shooter conveyed that he had calmed down and felt his typical depression return. This was the shooter's last outgoing e-mail.

Lastly, there was no evidence of communication or attempted communication contained within the content of the e-mails (sent or received by the shooter) that indicate there were persons and/or co-conspirators, involved in the planning, execution, and/or cover up of the Sandy Hook Elementary School shooting --->
