SUPPLEMENTAL REPORT: Review of Exhibit # 00375

ACTION TAKEN: On 09/06/2013, this Detective seized records pursuant to a Search and Seizure Warrant executed upon Nexon America, Inc. After a comprehensive review of said records, this Detective identified an additional e-mail address: "**kaynbred@gmail.com**" contained within the shooter's "Nexon User Profile."

At the request of State's Attorney Stephen Sedensky, the Connecticut State Police prepared a Search and Seizure Warrant for all records associated with the Google, Inc. account: "**kaynbred@gmail.com**" for the time frame of January 1st, 2009 thru December 31st, 2012. On 09/23/2013, a Connecticut Search and Seizure Warrant was issued and executed upon Google, Inc. On 12/02/2013, the records were seized by this Detective and a review of said records yielded the following results:

The gmail account was created on 01/01/2009 at 0225 hours.
The gmail account contained a total of sixty-four (64) e-mails.
Thirteen (13) e-mails spanned the dates: 04/10/2012 - 11/08/2012.
Fifty-one (51) e-mails spanned the dates: 01/01/2013 - 09/14/2013.

The content of the e-mails was exclusively SPAM and/or advertisement-related material that ranged from Internet-based video game coupons to Vegetarian How-Tos containing Vegan recipes to numerous offers from "Medic.Canada" (a known SPAM e-mail virus).

There were no personal correspondences (e-mails) contained within any of the records seized ---> Please refer to Exhibit # 00375 for additional details.
