Sherry stated that she had e-mailed me the only assignment for that day on July 17th, 2013. I requested that Sherry re-submit the request, which she did. The Troopers assigned to the job site were Tfc. Debbie Jeney and Det. Pedro Rosado. The construction did not start until 1930 hours that day (See attached e-mail.)
