# Friday, December 14, 2012

Western District Major Crime Squad:

Van assigned to process the interior scene at Sandy Hook Elementary School.

Detectives arrived at Sandy Hook Elementary School and assisted first responders with searching the school, locating victims and searching for any additional shooters. After securing the scene, Detectives were assigned and paired up with federal agents to conduct multiple interviews and neighborhood canvasses. Detectives were also assigned to assist identifying the deceased as well as investigate the report of a second shooter at Griffin Hospital. Detectives also began to conduct a background investigation on the shooter and his family. Detectives were assigned to interview and identify victims being transported to Danbury Hospital. Detectives were assigned with identifying all staff members present during the shooting incident.

Central District Major Crime Squad:

Van assigned to process the exterior scene at Sandy Hook Elementary School. Primarily tasked with establishing a temporary morgue in conjunction with OCME which was used to identity and document school victims.

Detectives were assigned and paired up with federal agents to conduct multiple interviews and neighborhood canvasses. Detectives were assigned to assist in the identification of deceased as well as investigate the report of a second shooter at Griffin Hospital. Detectives also prepared multiple search warrants for various locations, vehicles and electronic devices. Detectives were assigned to interview and identify a victim transported to Bridgeport Hospital. Detectives prepared multiple search warrants for various locations, vehicles, electronics including the above stated crime scene.

Eastern District Major Crime Squad:

Assigned to process the scene at 36 Yogananda Street.

Emergency Services Unit:

ESU dispatched to the Sandy Hook Elementary School to conduct a secondary scene search and cleared the school. Upon learning that there was a second scene at 36 Yogananda Street, ESU responded to that address and cleared the residence.

# Saturday, December 15, 2012

Western District Major Crime Squad:

Van continued to process the interior scene at Sandy Hook Elementary School.

Detectives, with the assistance of federal agents, continued to conduct multiple interviews and neighborhood canvasses. Detectives continued to develop information on the shooter and his family. Detectives with the assistance of federal agents have been investigation numerous phone calls made to multiple families throughout Newtown. The caller stated that he is Adam Lanza and is he going to kill them. These phone calls have continued on a regular basis. Detectives with the assistance of federal agents have been investing multiple offensive and suggestive social media web posts. These investigations are actively being pursued, with much success of getting websites/posts, etc., removed.

Central District Major Crime Squad:

Van was assigned to attend autopsies of the deceased students and teachers. Van assigned to process the exterior scene at Sandy Hook Elementary School.

Detectives, with the assistance of federal agents, continued to conduct multiple interviews and neighborhood canvasses. Detectives also prepared a search warrant for the shooter's GPS device.

Eastern District Major Crime Squad:

Continued to process the scene at 36 Yogananda Street.

Special Licensing and Firearms Unit:

Detective Barbara Mattson was assigned to search all firearm transactions for Nancy, Peter and Adam Lanza to include permits, registered weapons etc...

## Sunday, December 16, 2012

Western District Major Crime Squad:

Van continued to process the interior scene at Sandy Hook Elementary School.

Detectives, with the assistance of federal agents, continued to conduct multiple interviews and neighborhood canvasses. Detectives continued to develop information on the shooter and his family. Detectives with the assistance of federal agents have been investigation numerous phone calls made to multiple families throughout Newtown. The caller stated that he is Adam Lanza and is he going to kill them. These phone calls have continued on a regular basis. Detectives with the assistance of federal agents have been investing multiple offensive and suggestive social media web posts. These investigations are actively being pursued, with much success of getting websites/posts, etc., removed.

Central District Major Crime Squad:

Van assigned to process the exterior scene at Sandy Hook Elementary School.

Detectives were assigned to investigate a report of a bomb threat at St. Rose of Lima Church in Newtown.

Detectives were assigned to investigate the potential involvement of the Westboro Baptist Church at the victim's funerals as well as the counter resistance efforts from the Hell's Angels Motorcycle Club.

### Eastern District Major Crime Squad:

Continued to process the scene at 36 Yogananda Street. Transported evidence collected from the scene to Troop A.

#### Emergency Services Unit:

Assigned to provide security at various funeral services for the victims.

### Computer Crimes Unit:

Assigned to seize any additional electronic or computer equipment from the residence at 36 Yogananda Street.

# Tuesday, December 18, 2012

#### Western District Major Crime Squad:

Van continued to process the interior scene at Sandy Hook Elementary School. Van began packaging the clothing of the victims.

Detectives, with the assistance of federal agents, continued to conduct multiple interviews and neighborhood canvasses. Detectives continued to develop information on the shooter and his family. Detectives continued to investigate the potential involvement of the Westboro Baptist Church at the victim's funerals as well as the counter resistance efforts from the Hell's Angels Motorcycle Club. Detectives with the assistance of federal agents have been investigation numerous phone calls made to multiple families throughout Newtown. The caller stated that he is Adam Lanza and is he going to kill them. These phone calls have continued on a regular basis. Detectives with the assistance of federal agents have been investing multiple offensive and suggestive social media web posts. These investigations are actively being pursued, with much success of getting websites/posts, etc., removed.

## Wednesday, December 19, 2012

No members of the Westboro Baptist Church arrived at the funeral, however over 300 counter protestors arrived, no incidents reported. Detectives with the assistance of federal agents have been investing multiple offensive and suggestive social media web posts. These investigations are actively being pursued, with much success of getting websites/posts, etc., removed.

### Central District Major Crime Squad:

Van continued to search premises of Yogananda Street for items of evidentiary value and to conduct an inventory (Secondary crime scene).

Detectives, with the assistance of federal agents, continued to conduct multiple interviews and neighborhood canvasses. Detectives continued to develop information on the shooter and his family.

## Emergency Services Unit:

Continues to provide security at various funeral services for the victims.

Emergency Services Unit:

Continues to provide security at various funeral services for the victims.
