Action Taken: On Friday, December 14, 2012, Trooper McDonald #951 and this investigator were assigned to interview and photograph Sandy Hook Elementary School [REDACTED] 04, 03 had been injured in the shooting and was subsequently transported to Bridgeport Hospital for treatment. Trooper McDonald obtained a signed statement from [REDACTED] 04. This investigator took six (6) digital photographs of [REDACTED] 04 as she awaited surgery on her injured left foot.

All photographs were taken by this investigator utilizing a Central District Major Crime Squad Nikon D-300s Digital Camera and Nikon Speedlight SB-910 Flash with a SanDisk Extreme III 2.0 GB Compact Flash digital memory card. These images were later downloaded onto a compact disc and the disc was then submitted to the Department of Public Safety, Division of Scientific Services, Forensic Science Laboratory Photography Unit, and printed as photographs as well as recorded onto a compact disc. The Photography Unit will maintain an electronic file that contains these images and the images can be reproduced in the future upon request.
