ACTION TAKEN:

Following the Sandy Hook Elementary School shooting on 12/14/12, the Connecticut State Police Western District Major Crime Squad was assisted in the investigation by several federal agencies to include the Federal Bureau of Investigation (FBI). Supervisory Special Agents Andre Simons and Molly Amman from the FBI Behavioral Analysis Unit 2 (BAU-2) were assigned to assist in gathering information about the shooter, Adam Lanza. Simons and Amman composed a questionnaire to be used by law enforcement officers during interviews to gather the necessary information about Lanza. The information gathered, to include personal, medical and psychological history, may assist in identifying the possible motivation behind the attack at Sandy Hook Elementary School. A copy of the questionnaire is attached to this supplementary report.
