CONSENT FORM- Samuel Starks

ACTION TAKEN: On January 23, 2013, at approximately 1200 hours, I met with attorney Samuel Starks at his office located at 1100 Summer Street, 1st floor, Stamford, CT. Attorney Starks was appointed by probate court as the executor of Nancy Lanza's estate. Prior to our meeting I was informed by Sgt. Pattberg that attorney Starks had numerous pieces of mail addressed to 36 Yogananda Street Sandy Hook, CT that he had received from the post office. After speaking with attorney Starks I explained that it was possible individuals may have sent threatening, or dangerous items in the mail based on the magnitude of this incident. I further explained that the best course of action was to have these items opened and examined by members of the Connecticut State Police trained to deal with any possible threats. Attorney Starks agreed, and provided me with a written consent to search said items. Attorney Starks then turned over numerous pieces of mail which I transported to Troop G in Bridgeport where it was secured in the Major Crime office.
