Action Taken: On 12/18/12 at approximately 1500 hours, Detective Grandpre #1220 turned over two items of evidence seized in conjunction with the ongoing investigation under companion case number CFS-1200705354.

The first item of evidence was identified as Exhibit #0027A, One (1) Memorex recordable compact disk containing extracted data from Exhibit #27, an LG cellular telephone, seized with a search warrant under case number CFS-1200705354.

The second item of evidence was identified as Exhibit #005A, One (1) San Disk Cruzer Glide 32GB USB Flash Drive containing extracted data from Exhibit #5, an Apple Iphone, seized under case number CFS-12-00705354.

This Detective transported both items of evidence to Troop A, Southbury, where both exhibits were processed, packaged, sealed and labeled, per CSP protocol, before being placed into Evidence (See attached JD-CR-18's.)

The status of the case remains actively under investigation.
