Meyer, this Detective, Detective Peters, and the 01 02 03 12 discussed the goals of the interview, which are not to assist with the investigation, but rather to help their son process the event and talk about it, and that Meyer could then, as a clinician and licensed counselor, assist in assessing some of the needs of 01 02 03 12 and make recommendations for therapy or counseling. Meyer relayed that this interview would be terminated if showed any signs of decompensation or any renewed signs of trauma. It was clearly explained to the 01 02 03 12 that this interview was being conducted because they felt it was in the best interest of their son, and that the investigation would still be thorough even without the interview of their child, or any of the other children from the school.

01 02 03 12 stated that they were comfortable with moving forward, and advised that they hoped that the interview might also yield information that would also assist in filling in any gaps or answering any outstanding questions that remained. 01 02 03 12

already expressed her feelings to this Detective, felt at a disadvantage and had a "need for accuracy" regarding what their child had experienced or saw or heard the day of the shooting. **01 02 03 12** admitted to struggling with how they can help**10 01 02 03 12** when only the police know whether what they are recalling is accurate, and when they are hearing so many opposing details from the media. It was expressed that in addition, some of the trauma personnel that various families had seen, including their own, had relayed that the need for truthful and correct information would assist them in processing and healing.

As was done with 01 02 03 12, this Detective showed 01 02 03 12 a simplified map of the entrance to the school and the 1st grade hallway and stated and showed them that what was known at this time is that the shooter entered the lobby through the front glass area of the school, and ultimately walked to the left into the first grade wing, entering and shooting in both Rooms #8 and #10. It was explained that both the principal and school psychologist had been shot and killed in the hallway near the main entrance, and that we, as the police, were unsure as to what doorway many of the children had exited; and therefore cannot state for sure which students would have seen those victims.



was submitted into Evidence at Troop A (see attached JD-CR-18).

On 12/31/12, this Detective received an e-mail message from 01 02 03 12, inquiring about the scheduling of an informational meeting between the parents of the surviving children and the police. Additionally, the e-mail message advises that she had spoken with many of the parents of the surviving children and relayed that the majority of the children told them that the shooter had come into the classroom through the hallway door (see attached).

The status of the case remains actively under investigation.
