**ACTION TAKEN:**

On December 15th, 2012 at approximately 1945hrs, Detective Marc Grandpre and I spoke with and obtained a written statement from ██████████ 04 ██████████ was identified during this investigation as possibly being ██████████ 04 ██████████. As such, I was assigned to speak with ██████████ 04 as part of this investigation.

██████████ 04 resided alone at a single family home located at ██████████ 03 ██████████. He is employed as ██████████ 04 ██████████. He related that he has been ██████████ 04 ██████████ for the majority of his life. That approximately two years ago, he met Nancy Lanza in town and ██████████ 04 ██████████. He related that he knew, after the fact, about Adam Lanza being involved in the Newtown school shooting and also had been made aware of Nancy's death. ██████████ 04 appeared calm and un-emotional, presenting predominantly a flat affect. However, throughout the course of our meeting, he periodically paused during dialogue and/or excused himself to another room as he appeared to become upset while discussing his history with Nancy.

04 related that he had been expecting to be contacted by police at some point in light of recent events in Newtown. He was initially guarded during discussions related to 04. He described that it was 04 and that Nancy was as well a 04. As we spoke, 04 identified that one of his main concerns was the media obtaining the information that he was sharing regarding 04. I explained to 04 that our investigation was active and as such we were not releasing such information and related statements by witnesses to the media.

04 further related the he 04. That she went on a trip to New Hampshire Tuesday, December 11th, 2012. 04 left for a business trip on Wednesday, December 12th, 2012. He received a text message from Nancy at approximately 2200hrs on Thursday, December 13th in which Nancy informed him that she recently arrived home. That they last talked on Thursday, December 13th, 2012 at approximately 2222hrs. At that time he was in 04 and they discussed her trip and his business trip.

04 thereafter texted Nancy Friday morning, December 14th at approximately 1012hrs to say good morning. He did not immediately, or shortly thereafter, receive any response from Nancy, which 04 described as not being unusual. Later that day, 04 boss notified him of the shooting in Newtown. 04 searched the topic on-line and contacted family members in Newtown to make inquiries. He then attempted to contact Nancy on her home telephone and cellular telephone just around noon time with negative results. He described that Nancy's home telephone did not ring and went directly to voice mail. Sometime thereafter, 04 heard the name "Ryan Lanza" being talked about in connection with the shooting as well the incident taking place at Yagalanda Street. At this point 04 called a friend who confirmed Nancy's death.

04 related that he never thought Nancy's son Ryan would be involved in such an incident. He was aware that Nancy had another son, Adam, who suffered from Asperger Syndrome. He never met Adam and had only been inside Nancy's residence once, approximately a year and a half ago. That Nancy never related any incidents in which Adam was violent with her. However, 04 felt that Nancy did a lot for Adam to assure that he was happy and appeased.

04 related that during the time that he had known Nancy, she had shared with him that she owned guns and that she had been to a range target shooting with her sons.

In addition to the information contained in 04 statement, he verbally related to these Detectives that over the past year Nancy had shared with him her plans to sell her home in Newtown and move to either Washington or North Carolina. That she was originally going to downsize to a smaller

home in Newtown. However, she had conversations with her son Ryan about the idea of moving. 04 explained that it appeared that with Ryan living and working out of state and his desire to travel, there was no reason that she should restrict herself to living in Newtown.

According to 04 Nancy had planned to have her house painted over this past spring in preparation for putting it up for sale. However, the painting plan did not come to fruition and the sale of the house was postponed. Further, 04 related that Nancy knew that she was not going to be able to effectively show / sell her home while Adam was living within. Her plan was to purchase an RV (Recreational Vehicle) to facilitate their move to either Washington State or North Carolina. During their trip, 04 related that Nancy would then sleep in a motel / hotel and Adam would sleep in the RV as he would not sleep in a motel / hotel. In this process, she could have Adam out of the house, they could effectuate their move and meanwhile sell her house.

04 related that it was his understanding that if Nancy were to move to Washington State, it was for the purpose of enrolling Adam in a special school that he wanted to attend. If they were to move to North Carolina, it was going to be for the purpose of obtaining employment for Adam and making him more self sufficient. That Nancy had related to 04 that she had a friend, "John", who owned a computer technologies business in North Carolina. That John had agreed to mentor Adam and teach him the business. (See Attached Written Statement)

RELATED EVIDENCE:

During my interview with 04 he referenced his cellular telephone for obtaining dates and times of communications that he had with Nancy Lanza. He allowed me to view and visually verify the related text message communications. He showed me one text message dated Monday, December 10th, 2012 with a time stamp of 1151hrs. The message was received from Nancy Lanza and related that she had gotten off to a rough start that day. That Adam had "bumped his head" "really bad" and they were dealing with blood at 5:30 in the morning.

I explained to 04 that his cellular telephone contained communications known to me, and presumably some communications not yet viewed, that were considered to have evidentiary value. That this information on his cellular telephone could help identify critical timelines related to time of death and possibly identify precipitating circumstances leading up to Nancy's death. As such, I was obligated to seize his telephone at this time and apply for a search warrant to search its contents. I explained that I also could accept 04 written consent to search his telephone in which case the process of extracting the related information and returning his telephone could be effectuated this same day. On Sunday, December 16th, 2012 at approximately 1105hrs, 04 verbally agreed to provide consent and thereafter completed a written consent form. (See Attached Form)

I thereafter secured [04] cellular telephone and transported it the Computer Crime & Electronic Evidence Unit at the Forensic Science Laboratory in Meriden CT. The phone was processed by Trooper George Jupin. At approximately 2110hrs, Trooper Jupin provided me with a DVD containing the data seized from [04] cellular telephone. I transported the DVD to Troop L in Litchfield where I packaged and processed the DVD as evidence exhibit #338: One (1) DVD marked "Samsung Galaxy S", containing data extracted from the personal cellular telephone of [04] [04]. I completed a JD-CR-18 and Evidence Flow Sheet and secured the exhibit in the CI Temporary Evidence Locker. It was thereafter secured in WDMC Evidence Room. All related paperwork was turned over to Detective Steven Rupsis. (See Attached JD-CR-18 Copy)

CASE STATUS:

This case remains active pending further investigation.
