Action Taken:

On 12/14/12 at approximately 0930hrs this Trooper was working at Troop A in Southbury as the Master Sergeant to the barracks. I heard though the overhead speaker the Troop A dispatcher indicate that there was an active shooter in Newtown. Lt. Hofbauer and I immediately went into the Troop A dispatch area to attain more facts pertaining to the incident. After learning the exact location I left Troop A enroute to the Sandy Hook elementary School in Newtown. As I entered I-84 West I turned on my lights and sirens, which triggered my MVR to begin taping. I was traveling in my assigned department cruiser (CT) 138 UTZ. I arrived at the Sandy Hook scene directly behind Lt. Hofbauer and entered the building from the front entrance. After returning to my vehicle, when the scene was calm, I observed that my MVR had continued taping throughout the incident. I gave the hard drive of the MVR system to Sgt Mullai, who turned it over to Sgt Boroski for processing. This is my best recollection of events at this time. See aftached JD-CR-18.

Note: Due to my promotion on 12/14/12 the JD-CR-18indicates my current rank of Lt, however I was a Master Sergeant at the time of the incident.
