CONSENT FORM- Ryan Lanza

ACTION TAKEN: On January 17, 2013, at approximately 1600 hours, I spoke to attorney Michael English regarding mail addressed to 36 Yogananda Street Sandy Hook, CT. I had learned that attorney English was representing Ryan Lanza who is the executor of the property located at 36 Yogananda Street Sandy Hook, CT. I explained to attorney English that we had numerous pieces of mail addressed to the Lanza residence that were currently being held at the Newtown Police Department. I explained that it was possible individuals may have sent threatening, or dangerous items in the mail based on the magnitude of this incident. I further explained that the best course of action was to have these items opened and examined by members of the Connecticut State Police trained to deal with such items. Attorney English agreed, and I requested Ryan Lanza provide a written consent to search said items. I then emailed attorney English at menglish@fdh.com a Consent to Search And Examine Evidence form DPS -167-C which I had completed prior to sending. Attorney English advised me that he was meeting with Ryan Lanza later that evening and would present the form to him.

On January 18, 2013 attorney Michael English contacted me and advised me that his client Ryan Lanza signed the form as requested. He then emailed me a copy of said form which I then printed and signed as a witness.
