On 03/06/13, I was assigned to review downloaded data from a Samsung Model SCH-A650 cell phone (exhibit #348). According to the report of the download, conducted by Detective Ferrucci from the State Police Computer Crime and Electronic Evidence Unit on 12/21/12, the phone number that was previously assigned to the phone was **103 103** (see attached download report). It was learned through this investigation that the phone number belongs to Ryan Lanza's current cell phone. Based on my findings, the Samsung cell phone was an inactive phone which previously belonged to Ryan Lanza.

A review of the contents of the 133-page "Paraben Corporation" phone download report revealed a "recent calls" log dating from May 7, 2007 at 1725 hours through August 23, 2007 at 1226 hours and included 58 calls. The calls were broken down as 20 outgoing calls dating from July 12, 2007 through August 23, 2007; 20 incoming calls dating from June 26, 2007 through August 22, 2007; and 18 missed calls dating from May 7, 2007 through August 23, 2007. The download report further revealed 15 SMS text messages dating from July 4, 2007 through August 21, 2007 and 37 bookmarks with no identifiable dates. Many of the bookmarks were similar or identical to the SMS text messages. According to the report, there were no identified emails on the phone. Due to the age and model of the phone, it did not have the capability to accept emails.

After review of the content, there is no remarkable data which I would deem to be useful in this investigation.

CASE STATUS:

This case remains ACTIVE pending further investigation.
