retrieved from the Lanza residence at 36 Yogananda St. in Newtown. According to the report, the phone number assigned to the phone is 03,05 Through our investigation, we have identified this phone number as a number identified through Nancy's cell phone contacts as Adam's Cell phone. According to the report, there is no retrievable data available to include Contacts, SMS Text messages, Incoming/Outgoing Call Records, Images or Audio/Video (see attached report). Screen shots of the phone only revealed two calls made or received on the phone. On May 15, 2011 at 1820 hours a phone call is received from phone number 03 which lasted approximately 36 seconds. A check of the phone number through fonefinder.com indicated that the phone number belongs to a Verizon Wireless cellular phone from New York. On December 4, 2011 at 1316 hours, a call was made to phone number 203-426-8167/Lanza residence and lasted 8 seconds (see attached screen shots).

Based on the lack of any useful information, it appears that this phone had very minimal use.
