ACTION TAKEN:

On 03/06/13, I was assigned to review the Cellebrite download (Exhibit 5A) from the iPhone retrieved from Yogananda St. (Exhibit #5 under case number CFS-12-00705354). On 03/07/13 at approximately 0800 hours, I began reviewing the downloaded data to include Contacts, Recent Call Logs, SMS Text Messages, Images and Videos. The report indicates that the phone number assigned to that phone is 03, 05 [REDACTED]. Based on our investigation, we were able to determine that this phone belongs to and is used exclusively by Nancy Lanza. (Download Report is on attached thumb drive)

A review of the CONTACTS, revealed 55 entries consisting primarily of friends and family with a few business contacts. Based on the limited number of contacts and their relation to Nancy, there was nothing pertinent to report about the CONTACTS.

A review of the RECENT CALLS, revealed twenty-nine (29) incoming calls dating from 11/13/12 at 2335 hours (GMT) to 12/12/12 at 0318 hours (GMT), forty-seven (47) outgoing calls dating from 11/13/12 at 2318 hours (GMT) to 12/13/12 at 1741 hours (GMT), and twenty-four (24) missed calls dating from 11/15/12 at 1729 hours (GMT) to 12/14/12 at 2153 hours (GMT). The majority of the calls came from or were made to Ryan Lanza and 04 [REDACTED]. **Note-ten (10) missed calls came after Nancy's death between 1659 and 2153 hours (GMT) on 12/14/12.

A review of SMS TEXT MESSAGES AND MMS ATTACHMENTS, revealed thirty (30) MMS attachments consisting primarily of photos dating from 04/20/12 at 2134 hours (GMT) to 12/12/12 at 2252 hours (GMT) and six hundred and ninety-six (696) SMS text messages. The majority of the text messages are everyday texts between friends and family members discussing life in general (i.e. work, vacation, winter storm Sandy, etc.). There

were only two text messages in which Nancy references her son Adam.

-In message #338, Nancy texts "I REALLY wish I could but I have so much to do and want to spend a little extra time with Adam before I go. Also, lots of cooking to do because I like to leave him with all his favorites." 04 [REDACTED]

-In message #621, Nancy texts "I was off to a rough start. Poor Adam bumped his head (really badly) and we were dealing with blood at 5:30 in the morning : (He is ok... It looked worse than it actually is." 04 [REDACTED]

A review of IMAGES AND VIDEOS, revealed four hundred and ninety five (495) images dating from 12/09/11 at 1454 hours (GMT) to 12/13/12 at 1636 hours (GMT) portraying mostly vacation spots and visiting with friends. None of the images portray her sons Adam or Ryan. There are a few pictures of Nancy alone or with friends. There were seventy-one (71) videos dating from 12/10/11 at 1347 hours (GMT) to 09/03/12 at 0007 hours (GMT). The majority of videos were short, ranging in length from 2 to 30 seconds. The videos appear to be taken by Nancy while on vacation or visiting friends.

Aside from the two text messages in which she references Adam, there is nothing of significance to report from the download of Nancy Lanza's iPhone.

CASE STATUS:

This case remains ACTIVE pending further investigation.
