TFC WILLIAM BLUMENTHAL'S DASH CAM TIMELINE

ACTION TAKEN: On 01/31/13, the DVD of recordings from TFC William Blumenthal's vehicle video recorder was seized and entered as Exhibit #317 in this ongoing investigation. The DVD is a recording of events that took place at Sandy Hook Elementary School on 12/14/12. At the time that the video was recording, TFC Blumenthal's vehicle was parked in the parking lot of the SHES, facing the northwesterly (front) corner of the school building. The video is a forward facing view from the cruiser of the school parking lot.

The DVD is split into two sections with Video #1 beginning at approximately 09:38:01 hours and ending at approximately 10:02:31 hours. Video #2 begins at approximately 10:10:22 hours and ends at approximately 12:19:29 hours. The following is a timeline of pertinent events that were captured by the video recorder, and observed and recorded by me while watching this DVD:

Video #1

09:38:01 TFC Blumenthal #690 enroute to SHES.

09:52:58 TFC Blumenthal arrives on scene with TFC Christopher Zullo # 842.

09:57:38 TFC McGeever #837 running with **01 02 03 12**) across the parking lot toward the fire house.

09:59:34 TFC Kick # 811 driving Natalie Hammond (gunshot victim, room 9), in cruiser, to triage station.

10:22:16 Detective Van Ness #1431 escorting the [REDACTED] 04 [REDACTED]) from the school.

10:22:01 TFC Orlando Mo # 998 arrives on scene.

11:41:52 ESU seen searching roof of school.

12:09:14 Troopers gather with LT (MSGT) Davis #053 to prepare for search for Kaitlin Roig's cell phone.

12:19:13 TFC Blumenthal moves assigned cruiser, which now faces the wood line.

12:19:29 Recording stops.

***The time stamps on the dash cam videos are particular to that assigned cruiser and therefore may differ from the time stamps on the other dash cam videos. The dash cam video recorders are self programmed.

CASE STATUS: This case will remain active pending further investigation.
