**LT (MSGT) DAVIS' DASH CAM TIMELINE**

**ACTION TAKEN:** On 01/3/13, the DVD of recordings from LT (MSGT) Davis' vehicle video recorder was seized and entered as Exhibit #316 in this ongoing investigation. The DVD is a recording of events that took place at Sandy Hook Elementary School on 12/14/12. At the time that the video was recording, LT Davis' vehicle was parked in the parking lot of the SHES, behind the third row of cars, on the north side (front) of the building, facing west. The video is a forward facing view from the cruiser of the school parking lot.

The DVD is split into two sections with Video #1 beginning at approximately 09:41:28 hours and ending at approximately 13:04:59 hours. Video #2 begins at approximately 13:05:01 hours and ends at approximately 14:11:13 hours. The following is a timeline of pertinent events that were captured by the video recorder, and observed and recorded by me while watching this DVD:

09:41:28 LT (MSGT) Davis #053 enroute to SHES.

09:45:02 LT (MSGT) Davis arrives on scene with LT Hoffbauer # 040.

09:45:27 Sgt Cario #149 running toward the front entrance of the school, shortly followed by LT (MSGT) Davis.

09:46:02 TFC Kick #811 arrives on scene and drives to the front entrance of the school.

09:50:30 Oxford Police Officer Luke Ramirez escorts [REDACTED] 04 [REDACTED] toward the SH fire house.

09:51:51 SGT Roden #174 arrives on scene, runs to the front entrance of the school.

09:51:57 TFC Blumenthal # 690 arrives on scene, runs to the front entrance of the school.

09:52:36 TFC Zullo #842 arrives on scene, runs to the front entrance of the school.

09:54:55 Newtown Police Officer William Chapman carrying [REDACTED] 01 02 03 12 [REDACTED] across parking lot toward triage station. Chapman was assisted by LT Vanghele (white shirt), Newtown Police Department.

09:56:19 TFC McGeever #837 running with [REDACTED] 01 02 03 12 [REDACTED] across the parking lot toward the SH fire house.

09:57:18 Newtown Police Officer Scott Smith carrying [REDACTED] 01 02 03 12 [REDACTED] (child survivors from [REDACTED] 01 02 03 12 [REDACTED]) from the school to the parking lot, then running with them to the SH fire house.

09:58:27 TFC Kick # 811 driving Natalie Hammond (teacher and gunshot victim, room 9), in cruiser, to triage station.

10:05:25 TFC Keane #404 escorts a group of women and school children across parking lot to Detective Van Ness. All were escorted from the school by TFC Bennechi. The children are from Carol Wexler's classroom #7 and the women were in the PPT meeting in the conference room #9
