**TFC JOHN MCGEEVER'S DASH CAM TIMELINE**

**ACTION TAKEN:** On 12/18/12, the DVD of the recording from TFC John McGeever's vehicle video recorder was seized and entered as Exhibit #315 in this ongoing investigation. The DVD is a recording of events that took place at Sandy Hook Elementary School on 12/14/12. At the time that the video was recording, TFC McGeever's vehicle was parked in the third row of cars in the parking lot of the SHES, facing the north side (front) of the school building. The video is a forward facing view from the cruiser of the school parking lot, and captures the northeast corner of the building.

The DVD is comprised of one video, beginning at approximately 09:37:27 hours and ending at approximately 12:48:59 hours. The following is a timeline of pertinent events that were captured by the video recorder, and observed and recorded by me while watching this DVD:

09:37:48 TFC McGeever # 837 enroute to SHES.

09:48:40 TFC McGeever arrives on scene.

09:48:51 Captain Jose Rios (Newtown PD) approaches the driver's side of McGeever's vehicle with [REDACTED] 04 (parent) in handcuffs.

09:49:08 SGT William Cario # 149, TFC Christopher Kick #811 and Officer Leonard Penna (Newtown PD) walking from the front of the school.

09:51:25 Officer Luke Ramirez (Oxford PD) taking handcuffs off [REDACTED] 04.
