NEWTOWN POLICE DEPARTMENT OFFICER WILLIAM CHAPMAN'S (#98) DASH CAM VIDEO ENHANCED AUDIO VERSION

ACTION TAKEN: On 02/23/13, the DVD recording from Officer William Chapman's #98 (Car #18) vehicle video recorder, was seized from Sgt Wisentaner (Newtown PD) by Detective Mudry # 824 and entered as Exhibit # 356D in this ongoing investigation. The DVD is a recording of Off. Chapman's response to the Sandy Hook School shooting that took place on 12/14/12. The DVD recording was sent to the State Police Forensic Lab to be converted into working copies for the investigation. An enhanced audio version of the DVD was made in order to discern the sounds of gunshots heard, upon Off. Chapman's arrival to SHES, from the Newtown Police radio transmissions. This enhanced DVD was seized by me from the Connecticut State Police Forensic Lab on 03/26/13 and entered into evidence as Exhibit 356E.

The enhanced audio DVD is the exact same version of the recording that was submitted as Lab Submission # 032-M1 and made CSP Exhibit #356D. A separate and complete timeline report was completed for this video recording. The following is a brief timeline detailing the gunshots heard upon the arrival of Off. Chapman and Sgt Kullgren (Newtown) to SHES that was captured by the video recorder and observed and recorded by me while watching the DVD:

09:39:13 Off. Chapman and Sgt Kullgren arrive in the driveway of SHES, park adjacent to the ball field on the left, and exit their vehicles.

09:39:24 Newtown PD Dispatcher Nute (on the telephone with [REDACTED] 04) is heard on the police radio telling officers that "they still hear shooting".

09:39:26 The beginning of gunshots heard.

09:39:39 The last gunshot is heard.

I counted approximately 9 gunshots and the gunshots lasted approximately 13 seconds. The gunshots appear to be coming from the front of the school. The gunshots heard are slow in rhythm and in succession of each other. I was unable to discern between the gunshots from the AR-15 and the final suicide shot from the handgun.

CASE STATUS: This case will remain active pending further investigation.
