Action Taken: On Sunday, December 16, 2012, this investigator was assigned by Sgt Thomas #129, to locate and obtain consent from Sandy Hook Elementary School 04 vehicle, a blue Toyota Camry, CT registration 913UNY, was parked in the Sandy Hook Elementary School parking lot and was struck by a bullet during the shooting at the school.

Detective McDonald and this investigator then proceeded to the Reed Intermediate School in Newtown where the faculty from Sandy Hook Elementary School was meeting. We located 04 and informed her that her vehicle had been struck during the shooting and requested her consent to examine the vehicle. 04 gave her consent and signed the DPS-167-C, Consent to Search and Examine Evidence form. 04 then requested that we call her when we had completed the examination of her vehicle, and gave this investigator her cell phone number, which I wrote on the top of the form.

Detective McDonald and I then relayed the signed form to the Central District Major Crime Squad Van personnel who were at Sandy Hook Elementary School and notified them of her request to be contacted once they had completed the search of her vehicle.
