ACTION TAKEN: On Tuesday May 14, 2013, at approximately 1400 hours, Detective Rupsis and Lexamined certain items of evidence seized by the Central District Major Crime Squad from the Lanza residence in order to determine their potential value for further analysis by the Behavioral Analysis Unit (BAU) of the Federal Bureau of Investigation.

The following Exhibits were selected for further analysis by the BAU: Exhibits 606, 630, and 631. The Exhibits were removed by Detective Rupsis and stored in the WDMC Evidence locker for transportation to Troop A.

Additionally, it was determined that Exhibit 607, which consisted of three cassette tapes, would be sent to the Forensic Lab so that a working copy of the cassettes could be made for review by Detectives.
