ACTION TAKEN: On 06/25/13, I placed the telephone calls (911) made to Newtown Police Department on 12-14-12, from both 04 and Rick Thorne onto a CD. The telephone calls were part of Exhibit # 00336 (All 911 and routine telephone calls to/from Newtown PD on 12-14-12). During the play of the telephone call, gunshots can be heard at various times. The CD was submitted to the Forensic Lab with a request made to Lucinda Lopes-Phelan, Forensic Science Examiner II, to make enhancements to the audio portion of the CD so that the gunshots can be more distinctly heard.

On 06/26/13 at 0835 hours, I submitted the audio CD to Penni Rosen, Evidence Control Officer, at the Forensic Lab along with a DPS-997-C Request for Examination of Physical Evidence and an explanatory of my request. See attached.

I am submitting to you one (1) audio CD with two (2) audio recordings of two (2) separate 911 calls made to Newtown PD on 12-14-12 regarding the Sandy Hook Elementary School Shooting. The two recordings were copied from Exhibit # 00336.

Recording #1 – (OKB6(V#W00112215) 9:35:39 (time)

Under the original evidence submission, this call is located in the file "911 Trunk 1."

This is the 911 call from [REDACTED] 04 [REDACTED]. It is 24 seconds long. I can hear continuous rapid gunfire from 0:15 to 0:22 (seconds) of the telephone call.

Recording #2 – (OKB6)L5100312215) 09:36:13 (time)

Under the original evidence submission, this call is located in the file "911 Trunk 3."

This is the 911 call from Rick Thorne, the school custodian. It is 14 minutes and 43 seconds (14:43) long.

I can hear continuous gunfire (slower than call above) during the following times:

00:35-00:41 (gunfire sounds far away)

3:09-03:34 (continuous)

03:46-03:49 (continuous)

During recording #2, the radio transmissions and background noise from Newtown PD are obstructing the sound of the gunfire. Anything that we can do to get rid of that noise would be greatly appreciated.

I went over the telephone calls (enhancements) made to the CSP and made note of the following:

Item #2 is [REDACTED] 04 [REDACTED]'s telephone call, mother in the conference room #9. I hear gunshots during the following times:

03:22 to 03:40 (continuous)

Also I hear two separate single shots at 03:59 and 04:02

Item #7 is [REDACTED] 04 [REDACTED] telephone call, teacher that was shot in room 1. I can hear gunfire from 2:06 to 02:24. I can also hear one (1) single shot at 2:41.

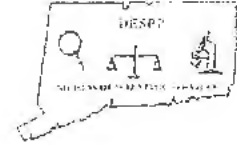
