NEWTOWN POLICE DEPARTMENT LIEUTENANT GEORGE SINKO #3 HQ DASH CAM VIDEO TIMELINE

ACTION TAKEN: On 02/23/13, the DVD of the recording from LT George Sinko's (Car # 17) vehicle video recorder, was seized from SGT Wisentaner (Newtown PD) by Detective Mudry # 824 and entered as Exhibit # 356A in this ongoing investigation. The DVD is a recording of LT Sinko's response to the Sandy Hook School Shooting that took place on 12/14/12.

During the recording of the video, LT Sinko was working an extra duty construction assignment with Brennan Construction. The assignment was located at the intersection of South Main Street (Rte 25) and Swamp Rd (Newtown/ Monroe town line). The video is a forward facing view from the cruiser. During the play of the video, it displays the title of "Car 17 Off Mulhall." His dash cam video was activated and the audio portion was recording during the construction assignment.

The DVD recording was sent to the State Police Forensic Lab to be converted into working copies for the investigation. The initial DVD recording was placed onto three separate DVDs. The recordings can be viewed on a Windows Media Player only. The video only provides a running time in increments of minutes and seconds. During the play of the video, the timer of the video runs in the lower right hand corner with the length of the video shown in the upper right hand corner of the video. The time stamp from the Newtown PD radio transmissions was used as a baseline to calculate the time that pertinent events were happening. The actual time of the event was calculated using the time stamp of the Newtown PD radio transmission plus or minus the run time of the video. The DVDs are broken down as follows:

11:16:27 (38:51) LT Sinko receives telephone call, leaves the construction assignment, and is en route to Sandy Hook Elementary School.

11:24:29 (41:21) LT Sinko arrives at Newtown PD.

Video ends with LT Sinko parked at Newtown PD.

DVD #1, Title 02, Fragment 01

Video begins and shows LT Sinko driving on Church Hill Rd to Sandy Hook Elementary School.

11:38:05 (02:48) LT Sinko arrives and parks his cruiser near the Sandy Hook Firehouse.

DVD #1, Title 03, Fragment 1

Video begins and shows LT Sinko driving from Sandy Hook Firehouse to Treadwell Park, for the staging of the media.
