NEWTOWN POLICE DEPARTMENT SURVEILLANCE VIDEO REPORT: EXHIBIT # 357

ACTION TAKEN: On 02/24/13, the DVD of the recording from the Newtown Police Department surveillance video was seized from SGT Wisentaner (Newtown PD) by Detective Mudry # 824 and entered as Exhibit # 357 in this ongoing investigation. The DVD is a recording of the police department's response to and the activitiy at the department after the Sandy Hook School Shooting that took place on 12/14/12. Audio was not available on the recording. The time stamp on the recording was inaccurate. This was proven when Officer William Chapman's Dash Cam video (which was determined to be time accurate) depicts him responding to SHES on Church Hill Rd prior to him leaving the police department building.

The DVD recording was sent to the State Police Forensic Lab to be converted into working copies for the investigation. The following is a brief summary of the pertinent events that can be seen on the video:

09:38:14 Newtown police officers rushing out of the building to respond to Sandy Hook Elementary School (camera # 09 and camera #10 view of the lobby/entrance.)

white mini van, carrying several survivor students from room 10, pulls into the parking lot and parks in the handicap parking spot by the front door of the police department (camera 15-front parking lot.) 09:57:05 Survivor students, 01 02 03 12 enter building with , another SHES mother, enters the building behind them (camera #9 and #10- lobby/entrance.) (in front) a SHES mother. 04 found the children running on Riverside Drive, near the corner of Cherry Street. 04 also stopped to assist Both women are mothers
