NEWTOWN POLICE DEPARTMENT OFFICER LIAM SEABROOK # 95 DASH CAM VIDEO TIMELINE

ACTION TAKEN: On 02/23/13, the DVD of the recording from Newtown Police Officer Liam Seabrook's (# 95) (Car # 13) vehicle video recorder, was seized from SGT Wisentaner (Newtown PD) by Detective Mudry # 824 and entered as Exhibit # 356C in this ongoing investigation. The DVD is a recording of Officer Seabrook's response to the Sandy Hook School shooting that took place on 12/14/12. The DVD recording was sent to the State Police Forensic Lab to be converted into working copies for the investigation. The initial DVD recording was placed onto two separate DVDs.

During the recording of the video, Officer Seabrook was parked in the parking lot of the SHES, facing the northwest (front) side of the school, between the second and third row of cars from the front. The video is a forward facing view from the cruiser. During the play of the video, it displays the title of "Car 13 Off Chapman 098."

Video #1 (Lab Submission # 031-1M1) begins at approximately 0933 hours and ends at approximately 1033 hours. Video #2 (Lab Submission # 031-2M1) begins at approximately 1034 hours and ends at approximately 1523 hours . The following is a timeline of pertinent events that were captured by the video recorder and observed and recorded by Newtown PD Officer Jeff Silver and myself while watching the DVDs:

09:33:47 Off. Seabrook running radar on Meadowbrook Rd, Newtown (located near the town border with Monroe, off Rte 25, Main Street).

09:34:37 Off. Seabrook initiates motor vehicle stop on Meadowbrook Rd.

09:36:13 Off. Seabrook hears call dispatched regarding shooting at SHES, returns paperwork to subject of motor vehicle stop and runs to cruiser.

09:36:25 Off. Seabrook en route to SHES via Rte 25, Main Street.

09:41:05 Off. Seabrook meets up with Newtown PD LT Vanghele (driving a department SUV) at the intersection of Church Hill Rd and Connors/Wire Rd.

09:42:27 Off. Seabrook enters Dickinson Drive.

09:42:47 Off. Seabrook arrives and runs to the left side (northeast) of the school to Off. McGowan's location near the playscape. LT Vanghele drives toward the front entrance of the school.

09:44:33 Activity is observed at the front door of the school (persons are indistinguishable).

09:46:31 Newtown Off. Hull arrives from his HCP assignment near Botsford Hill. Off. Hull parks perpendicular to the front of Off. Seabrook's vehicle, adjacent to the second and third row of parked vehicles in the parking lot, facing the front of the school. Off. Hull runs toward the front entrance of the school.

09:46:52 CSP LT Hoffbauer seen running to the left of Off. Hull's vehicle between the first and second row of cars toward the front entrance of the school. This marks the arrival of LT Hoffbauer.

09:46:55 CSP SGT Cario seen running toward the front entrance of the school. This marks the arrival of SGT Cario.

09:46:58 CSP LT (MSGT) Davis seen running toward the front entrance of the school. This marks the arrival of LT Davis.

09:48:40 Newtown PD Captain Rios with [REDACTED] 04 (parent) in custody walking from the playground area.

09:49:38 CSP TFC McGeever arrives on scene. Parks his cruiser in the third row of parked cars in the school parking lot.

09:50:20 Captain Rios turns custody of [REDACTED] 04 over to Oxford Off. Luke Ramirez.

09:50:39 Newtown Detectives McAnaspie and Joudy arrive on scene and head toward the playscape area of the school.

09:51:00 Unknown responder arrives carrying medical bag.

09:59:01 TFC Kick driving Natalie Hammond (teacher and gunshot victim, room 9), in cruiser, to triage station.

10:02:11 A black SUV being driven by LT Vanghele with SGT Cario, bringing [REDACTED] 01 02 03 12 (child victim) to the triage station.

10:07:05 CSP TFC Cournoyer escorts [REDACTED] 04 (teacher and gunshot victim [REDACTED] 04 across the parking lot to the triage station.

10:09:02 Newtown Officers (Seabrook and Smith) seen searching the roof of the school.

10:09:34 CSP TFC Bell arrives on scene.

10:10:02 CSP TFC Dennis Keane running to the northeast corner of the school building to assist with escorting children from the school to the firehouse.

10:51:47 Officers conducting a search with police canines.

11:18:13 SWAT/ESU members on roof of school.

11:47:54 SWAT/ESU leaving the school.

11:52:39 SWAT/ESU leaving the school.

11:54:27 Off. Seabrook's cruiser moved and is now facing the front of the school (northeast corner) near the first row of parked cars.

13:18:51 SWAT/ESU heading toward the front entrance of the school

13:48:17 SWAT/ESU leaving the school.

15:23:59 Off. Seabrook's cruiser is moved again and the tape ends.

During the playing of video #2, several members of the Newtown Police Department, Connecticut State Police, SWAT personnel, area Police Departments, Firefighters, and EMS personnel can be seen moving about the parking lot.

The time of the event was obtained by comparing the time stamps on the dash cam videos to the time stamps from the Newtown PD radio dispatch transmissions. The times were found to be the same.

CASE STATUS: This case will remain active pending further investigation.
