NEWTOWN POLICE DEPARTMENT OFFICER WILLIAM CHAPMAN #98 DASH CAM VIDEO TIMELINE

ACTION TAKEN: On 02/23/13, the DVD of the recording from Newtown Police Officer William Chapman's (# 98) (Car # 18) vehicle video recorder, was seized from SGT Wisentaner (Newtown PD) by Detective Mudry # 824 and entered as Exhibit # 356D in this ongoing investigation. The DVD is a recording of Officer Chapman's response to the Sandy Hook School shooting that took place on 12/14/12. The DVD recording was sent to the State Police Forensic Lab to be converted into working copies for the investigation.

During the recording of the video, Officer Chapman was parked in the driveway of the SHES, to the right of the ball field, facing the northeast (left) side of the school. Newtown PD SGT Kullgren's department SUV is parked to the right and just ahead of Off. Chapman's cruiser. The video is a forward facing view from the cruiser. During the play of the video, the title of the video is seen as "Car 18 Off. Hayes # 99."

Video #1 (Lab Submission # 032-M1) begins at approximately 0937 hours and ends at approximately 1321 hours. The following is a timeline of pertinent events that were captured by the video recorder and observed and recorded by Newtown PD Officer Jeff Silver and myself while watching the DVDs:

09:37:39 Off, Chapman en route to SHES from the police department. Newtown SGT Kuligren is the lead car in the black SUV. Newtown Off. McGowan is driving directly in front of Off. Chapman.

09:38:54 Off. McGowan breaks off to the right toward Crestwood Drive (located behind SHES).



The time of the event was obtained by comparing the time stamps on the dash cam videos to the time stamps from the Newtown PD radio dispatch transmissions. The times were found to be the same.
