SUMMARY OF EVENT:

12/14/2012 Recovery of Firearms at the Sandy Hook Elementary School in Newtown, CT: On 12/14/2012, four firearms were recovered at Sandy Hook Elementary School in Newtown, CT as a result of the investigation of the mass shooting by Adam LANZA (W/M/DOB: 04/22/1992). The firearms were traced by the National Tracing Center and were determined to be legally purchased by LANZA's mother, Nancy Lanza (W/F/DOB: 09/06/1960).

NARRATIVE:

- 1. On 12/14/2012 at approximately 9:50 AM, Adam LANZA (W/M/DOB: 04/22/1992) entered the Sandy Hook Elementary School in Newtown, CT and shot and killed twenty (20) students and six (6) faculty members.
- 2. The following firearms were recovered at the scene:
 - A Bushmaster model XM15, .223 caliber semi-automatic rifle, serial number L534858 was recovered near LANZA's body. A trace of the firearm revealed that that the firearm was purchased by Nancy Lanza (W/F/DOB: 09/06/1960) on 03/29/2010 from FFL 30 located at 30 CT.
 - A Glock model 20SF, 10 MM semi-automatic pistol, serial number SMA461 was recovered near LANZA's body. A trace of the firearm revealed that that the firearm was purchased by Nancy Lanza (W/F/DOB: 09/06/1960) on 01/05/2012 from FFL ocated at 30 CT.
 - A Sig Sauer model P226, 9 MM semi-automatic pistol serial number UU676027 was recovered near LANZA's body. A trace of the firearm revealed that that the firearm was purchased by Nancy Lanza (W/F/DOB: 09/06/1960) on 03/16/2011 from FFL located at CT.
 - An Izhmash (IMEZ) model Saiga-12, 12 gauge semi-automatic shotgun, serial number H08402282 was recovered from a vehicle registered to Nancy Lanza that was parked in the Sandy Hook Elementary School parking lot. A trace of the firearm revealed that that the firearm was purchased by Nancy Lanza (W/F/DOB: 09/06/1960) on 04/10/2010 from FFL 30 flocated at CT.
