TRANSCRIPTION OF **04** (GUNSHOT VICTIM IN ROOM #1) 911 CALL TO BOTH STATE AND NEWTOWN POLICE

ACTION TAKEN: In this investigation, I was assigned to transcribe the 911 call made by teacher **04**, a gunshot victim of the Sandy Hook School Shooting. **04** was shot in the foot during the school shooting and was located in room #1 during the call. The purpose of transcribing the telephone call was to assist in putting together a timeline for the school shooting.

The telephone calls and Police radio transmissions were obtained from the centralized dispatch center of Troops A, B, and L for the date of 12-14-12 from approximately 0930 hours to approximately 1030 hours. The first portion of her telephone call, which was received by the Connecticut State Police is part of an exhibit that was previously entered into evidence: Exhibit # 349: CSP 911 calls and police radio transmissions. The telephone call is located in the file "Item #7" of 172 items, the first half hour of transmissions. The first portion of the telephone call is a conversation between teacher **04** and Sergeant Michael Roach. The second portion of the telephone call is a conversation between teacher **04** and Dispatcher Jennifer Barocsi. The second portion of her telephone call is part of exhibit #336: Newtown Police Department 911 and routine calls to/from the PD. The call to the state police was transferred to Newtown PD and is located in the file named "911 Station 3".
