TRANSCRIPTION OF [REDACTED] 04) 911 CALL TO THE NEWTOWN POLICE

ACTION TAKEN: In this investigation, I was assigned to transcribe the 911 call made by Sandy Hook School Elementary School 04 [REDACTED]. At the time of the telephone call, 04 [REDACTED] was hiding under a desk with 04 [REDACTED] located in the back of the main office of the school. 04 [REDACTED] called 911 from telephone number (203) 426-7657 (SHES) and called right after the shooter left the office. The call was received by Newtown PD at 09:35:39 AM. The purpose of transcribing the telephone call was to assist in putting together a timeline for the school shooting.

The 911 call is part of exhibit #336: Newtown Police Department 911 and routine calls to/from the PD. The call located in the file named "911 Trunk 1."

The following is the transcription of the 911 telephone call:

Dispatcher Nute: "Newtown 911 what is the location of your emergency?"

04 [REDACTED]: "Hi, Sandy Hook School, I think there is somebody shooting in here... in Sandy Hook School"

Nute: "Ok, what makes you think that?"
