TRANSCRIPTION OF [REDACTED] 04 (PARENT IN CONFERENCE ROOM #9) 911 CALL TO THE STATE POLICE

ACTION TAKEN: In this investigation, I was assigned to transcribe the 911 call made by [REDACTED] 04 Sandy Hook School students. During the time of the shooting [REDACTED] 04 was present in conference room #9. The purpose of transcribing the telephone call was to assist in putting together a timeline for the school shooting.

The telephone calls and Police radio transmissions were obtained from the centralized dispatch center of Troops A, B, and L for the date of 12-14-12 from approximately 0930 hours to approximately 1030 hours. [REDACTED] 04 911 call is part of an exhibit that was previously entered into evidence: Exhibit # 349: CSP 911 calls and police radio transmissions. The telephone call is located in the file "Item #2" of 172 items, the first half hour of transmissions.

The conversation is between [REDACTED] 04 and Dispatcher Karen LaPrade. Towards the end of the telephone call, teacher [REDACTED] 04 takes over the telephone from [REDACTED] 04. The telephone call was answered at 09:38:43 AM.

The following is the transcription of the 911 telephone call:

LaPrade: "State Police Emergency ... is this the shooting in Newtown?"

[REDACTED] 04 "Yes.. .it is Sandy Hook School"

**04** "I have no children. I have 5 adults and one has been shot twice..it's been crazy"

Dispatcher LaPrade: "Ok ..Do you know (**04** interrupts "he's right..." ) where the shooter went?"

**04** "He's right outside the door"

LaPrade: "The shooter is right outside the door"

**04** "God ..he's ..he's shot a hundred times...he must have some big ( unintelligible)..."

LaPrade: "The shooter is right outside the door? Ok where are you in the building ma'am?"

**04** "When you come in the door make a left.. room nine"

LaPrade: "Ok ..Can you see the shooter?"

**04** "No I can't ..we're on the floor in the room"

04 "I'm here...he's outside the door"

LaPrade: "You just have a woman that was shot...can you..can you?..."

Dispatcher LaPrade: "um ..do you know how to.. administer ..um..first aid?"

LaPrade: "to stop ...you can't.. what's going on? ...talk to me"

04 "He's fuckin right outside the door..I don't want to move"
