ACTION TAKEN:

On 06/06/13 at approx. 1703 hrs., I seized a silver & copper colored metal fragment that was stuck in the wooden border of a display board that was on the hallway wall across from Room #9 in the Sandy Hook Elementary School (refer to Ex. #368). This fragment had been discovered by Newtown Police Officer Jeff Silver, who then advised me of its location. I placed the fragment in a "druggist fold" in a piece of notebook paper and then transported it to the WDMC-A office in Southbury. At approx. 1837 hrs. I secured it in the WDMC-A temporary evidence locker.

On 07/16/13 at approx. 1423 hrs., I took the fragment out of temporary evidence and processed it in accordance with CT State Police procedures. I also completed an Inventory Of Property Seized Without A Search Warrant form (SEE ATTACHED JD-CR-18). At approx. 1520 hrs. I placed the fragment in the Troop A temporary evidence holding locker #8.
