GARMIN NUVI 200 GPS TECHNICAL INFORMATION

ACTION TAKEN:

On August 12th, 2013 at approximately 1515 hours, I contacted Garmin Technical Support (1-800-800-1020), by phone to inquire about the technical specifications of the Garmin Nuvi 200 GPS unit. Betty, a technical support representative, stated that once the GPS unit is powered on, it will automatically identify its location through satellite reception and set the date and time accordingly. The GPS unit will not prompt you to set the date or time and can only be changed manually through the settings option. Once the unit is powered on, it will continue to utilize satellite reception for location purposes, however it will not record a "journey" unless a "final destination" is entered into the unit. A "final destination" requires a state, town, and street address to be entered directly into the unit. The GPS unit can not actively be traced and a "log" of recent destinations will be saved in the unit. Additionally, "favorites" or most frequently visited destinations, can also be entered and saved in the Garmin Nuvi 200 unit.

CASE STATUS: This case will remain active pending further investigation.
