ACTION TAKEN:

On 08/09/13 at approximately 1000 hours, I began to review the contents of several boxes of assorted documents which were seized from the Lanza residence at 36 Yogananda St. in Newtown, CT. The documents were subsequently forwarded to the Behavioral Analysis Unit of the Federal Bureau of Investigations to be reviewed. The documents have since been returned from the FBI.

On 08/16/13 at approximately 0900 hours, I retrieved box #5 of 5 of Exhibit FBI-1 from TFC Mo in the Troop A Evidence Room for review. A review of box #5 revealed the following items:

- -A photocopy of the shooter's Connecticut Learner Permit #168573202 dated 04/22/09.
- -Copy of a 9-page article about "Apraxia of Speech."


