(Transfer of Clothing - Exhibits #300 & #301)

ACTION TAKEN:

On 02/14/13 at approx. 0848 hrs., I took custody of exhibit #300 & #301 from the Troop A Evidence Officer, TFC Lonny Mo #998 at Troop A, Southbury. These exhibits were clothing worn by two of the victims that had been transported to Danbury Hospital. State's Attorney Stephen Sedensky had previously released these and other exhibits so that they could be returned to the victims' families; therefore from this point forward they were no longer held as evidence in this investigation.

At approx. 1330 hrs., I secured these items in the temporary evidence area within the Troop A locker room, which had been sectioned off as a safekeeping area and secured using evidence tape. The door to the locker room was double key locked.
