ACTION TAKEN: During the viewing and documentation of the dash camera videos from Newtown Police Department, it was discovered that the time stamps on the dash cam videos from the State Police were not correct. The Newtown Police Department videos were compared to the time stamp of their radio transmissions and were determined to be accurate. The State Police videos were then compared to Newtown Officer Chapman's video. The following errors were found on the dash cam videos:

The times reported on TFC William Blumenthal's dash cam video were found to be off by twenty (20) seconds. Therefore twenty (20) seconds needs to be added to the times reported.

The times reported on TFC John McGeever's dash cam video were found to be off by ten (10) seconds. Therefore ten (10) seconds needs to be added to the times reported.

The times reported on LT (MSGT) Michael Davis' dash cam video were found to be off by One (1) minute and twenty-one (21) seconds. Therefore one (1) minute and twenty-one (21) seconds needs to be added to the times reported.

CASE STATUS: This case will remain active pending further investigation.
